Warmest Greetings!

APIYN is a network of over 22 indigenous youth organizations in the Asia-Pacific region. The Network aims to contribute towards building the capacity and self-confidence of the indigenous youth in the Asia-Pacific region through providing systems of information, training, exchange and networking. It seeks to mobilize the catalytic role of the indigenous youth in developmental efforts by facilitating the exchange of ideas, analyses, and experiences, which they in turn can contribute and share with their indigenous communities.

In November 3-6, 2010, APIYN will organize an **Asia Pacific Climate Youth Camp to be held in Baguio City, Philippines**. This event will bring together 60 indigenous youth leaders from at least 12 countries in Asia and Pacific regions to discuss their situations and concerns in relation to climate change and IP rights, and formulate strategies for their engagement in COP16 of the UNFCCC, parallel activities of civil society and social movements and beyond.

We received a huge number of applicants for travel scholarship to participate in this event but due to our limited capacity to support airfares and other related expenses of interested participants we cannot accommodate them all. **Mr. Vinay Sabbithi of Association for Environment Conservation Advocacy & Solutions (AECAS)** is one of those promising IP youth leaders and we would like to endorse his application for support at your good institution.

His expenses will include a round trip economy ticket to and from the Philippines, a registration fee of 200\$ (to partly support food and accommodation expenses), local transportation cost and a travel insurance. The rest of the food and accommodation expenses and transportation to the community integration will be the responsibility of APIYN.

In line with this, we are asking your support for Mr. Sabbithi's participation to the Indigenous Climate Youth Camp in November. We believe that his participation in this event will hone his capabilities more as an indigenous youth to his community most especially at these times that issues like Climate Change continue to impede the development of indigenous communities and threaten their land, rights and welfare. Mobilizing young leaders like Mr. Sabbithi in this event will contribute to the empowerment of more indigenous communities, especially the indigenous youth in Asia and this cannot be possible without the support of likeminded institution like yours.

Thank you and we look forward to your favourable action.
